Proposal:
Post Season Playoffs
(1) Play-offs. Playoffs may be single elimination or two-out-of-three from bi-district to state. If neither method is mutually agreeable, a coin flip shall determine the play-off format.
(2) Two-out-of-Three Series. If schools play a two-out-of-three elimination series, the first (and only the first) game may be played prior to Friday, provided there is no loss of school time traveling to or participating in the game. Games 2 and/ or 3 shall not be played until Friday. If one game is played and a second game cannot be played because of weather, then the winner of the one game advances to the next round. If two games are played (and split) and the third game cannot be played on Saturday because of weather conditions, the third and deciding game shall be played on Monday Of the next week.

Section 481: GIFTS OR AWARDS TO SPONSOR OR COACH
Individuals who coach, direct or sponsor League activities in grades 9-12 may be suspended if:
(a) They accept more than $\$ 500$ in money, product or service from any source (over and above the stipend paid by the school district) in recognition of or appreciation for coaching, directing or sponsorship of League activities. The $\$ 500$ limit is cumulative for a calendar year and is not specific to any one particular gift.
