BASKETBALL NOMINATIONS ARE DUE BY FEB. 26TH!!!!

Coaches please make sure your Basketball nominations for All-State, All-State, Academic All-State, Athleteof-the-Year, All-Star Coaches, and Coach-of-the-Year are submitted to TGCA no later than noon on Monday, February 26th.

**The Varsity Coach of any athlete nominated for honors must be a current TGCA member in good standing in order for the nominated athlete to receive honors.

All-Star Nomination Guidelines:

- 1. All-Stars must be SENIORS.
- Coaches may nominate as many players as desired.
 All-Stars will be selected in two divisions: 1A, 2A, 3A and 4A, 5A.
- 4. Two athletes from the same school can be named to an All-Star team. (Clarification: The Basketball Committee will have the option of selecting two athletes from one school and one school only per all star team on a yearly basis).

- All-State Nomination Guidelines: 1. All-State players are NOT required to be SENIORS.
- 2. Coaches may nominate as many of their own players as they choose.
- 3. Stats are requested with the nomination.

Academic All-State Guidelines:

- 1. Academic All-State athletes MUST BE GRADUATING SENIORS.
- Must have an overall GPA of 94 for grades 9-11.
- 3. Must be a varsity participant in good standing and be of good moral character.

2006-07 Basketball Tournament Parking

Shuttle buses to and from Highland Mall *will not* be available throughout the basketball tournaments.

There are several parking garages available to the public on the University of Texas campus, as well as the area surrounding the Frank Erwin Center. Here is a brief list of some parking garages and locations around the Frank Erwin Center:

University of Texas-Trinity Parking Garage Located at the corner of Trinity and Martin Luther King Blvd. (MLK), one block northwest of the Frank Erwin Center. University of Texas-Brazos Garage

University of Texas-Manor Garage

Bob Bullock Texas State History Museum Parking

The Parking Garage entrance is located on the south side of the Museum on 18th Street, just off North Congress Avenue. The Museum's underground parking garage can accommodate vehicles with a maximum height of 7ft. There are two designated spaces for handicapped accessible vans with a maximum height of 8'2". Vehicles with a valid handicapped-parking permit may receive free

There is a pre-pay charge of \$5 at the garage. Visitors to the Museum will receive a \$2 rebate when they purchase Museum and/or Theater tickets, a Membership, or make a \$5 purchase in the Museum Store, provided that they present the cashier with their parking ticket.

Texas State Office Parking Garages/Lots

There are several state office parking garages and lots within walking distance of the Frank Erwin Center. These lots are reserved for state employees with a permit on Thursday and Friday until 6 p.m., but are available to the public for a fee after 6 p.m. on weekdays and all day Saturday.

This meeting was called to order by Alex Koulavatos, (Burkburnett H.S.), President of the Texas Girls Coaches Association.

Approval of Minutes - A motion was made by Janie Litchford (Frisco High School) to approve the minutes and seconded by Susan Willis (Kingwood High School)

Financial Report - Sam Tipton, Executive Director, presented the financial report to the board. Motion was made by Terry Lowry (Frenship High School) and a second made by Rodney Gee (Eastland High School).

Travel Report - Sam Tipton, Executive Director gave the travel report. Motion was made by Rodney Vigil (Roosevelt High School) and a second was made by Jim Eubanks (San Angelo Lakeview High School).

Itinerary Report - Sam Tipton, Executive Director, presented the itinerary report to the board. Motion was made by Rodney Vigil (Roosevelt High School) and a second made by Donna Benotti (Cy Fair High School).

2006-2007 Budget Report - Sam Tipton, Executive Director, presented the budget report to the board. Motion was made by Susan Willis (Kingwood High School) and a second made by Rodney Vigil (Roosevelt High School).

UIL Report - Rachel Harrison, UIL

Volleyball Committee Report - Jason Roemer, Committee Chair (Fredericksburg High School) proposed to increase the all-state team members in Volleyball from 25 to 30. A second was made by Donna Benotti (Cy Fair High School). Proposal passed.

Rodney Vigil (Roosevelt High School) proposed that the volleyball committee study having unlimited number of players nominated from one school on the all-state team. A second was made by Donna Benotti (Cy Fair High School). The proposal was passed with no recommendation from the Board to the committee.

Basketball Committee Report - Lynn Pool, Basketball Chair (Austin Bowie High School) reported no new business. She did give a report on a survey on the coaching box. It was reported that the majority surveyed wanted to increase the size of the coaching box.

Track Committee Report - Tim Torres, Track Committee Chair (Lubbock Coronado) reported no new business. He did bring up a couple of concerns: Lane 9 at the state meet (a wild card entry in the state meet), more relay marks as a point of emphasis, helmets for pole vaulters, and give the girls a 5 lb variance in the pole vault. Sam Tipton explained that the helmet issue is being studied currently by the UIL and the variance was not a favorable option by the UIL Medical Advisory Board.

Softball Committee Report - Mike Ledsome, Softball Committee Chair (Plano West) had "No report" from the Softball Committee.

Sub-Varsity Committee Report - Stephanie Shortes, Sub-Varsity Committee Chair (Frenship High School) had "No report" from the Sub-Varsity Committee.

Summer Clinic - Debra Manley, 1st Vice President reported that clinic planning is going well and she is still in need of high school speakers. Suggestion: The FCA breakfast in 2007 will not be part of the program.

Executive Committee Report - Leanne Johnston, Past President (Tyler Chapel Hill High School) proposed that an athlete can be an all-star in one sport only. A second was made by Donna Benotti (Cy Fair High School). Proposal passed and will become effective immediately.

New Business - Sam Tipton, Executive Director of TGCA wanted to remind everyone of the upcoming 80th Legislative session and be ready for proposed legislation.

Adjourn - Donna Benotti (Cy Fair High School) moved to adjourn. Kit Kyle (Marcus High School) Lynn Pool, Basketball Committee Chair seconded the motion.

Certification of District Representatives --

District Chairman will certify representatives on the UIL website. Playoff packets will be available to district representatives on the UIL website, www.uil.utexas.edu.

UIL Playoff Reporting Form -- Immediately following playoff games. This form is to be filled out on the UIL website by all district representative teams before the bi-district game. The winning school should fill the form out after each playoff game. There are two parts to this form. You will be asked to immediately following your game to either go online or telephone the UIL and tell who won the game and the score. The next school day you will need to go back online and fill out the form telling us the next round information. This information is very important. We will also use this information in our official record book. (UIL Website: www.uil.utexas.edu; Telephone Number: 512-232-4976).

Team Information Form -- The team winning the regional quarterfinal game in all conferences must fill the team information form out online at (www.uil.utexas.edu) and also send by overnight mail a team picture, picture of the head coach and copy of the school's mascot to the UIL office at 1701 Manor Road, Austin, TX 78722. Failure to submit this information may result in your school not appearing in the State Basketball Tournament program.

Team Picture -- We have expanded the state program to include pictures. For this reason we are asking that the team winning the quarterfinal game in all conferences must send by overnight mail a team picture, picture of the head coach, school's mascot and team

information form (fill out this online). Instead of mailing, you can email the pictures and logo to the UIL at pictures@mail.uil.utexas.edu. In the subject line of your email include your school name. The pictures must have a resolution of at least 300 dpi (dots per inch) to be acceptable. Failure to submit this information will result in your school not having their pictures in the State Basketball Tournament program. The following materials must be received in our office no later than Thursday, February 22 for Girls and Thursday, March 1 for Boys. The physical address for the UIL is 1701 Manor Road, Austin, Texas 78722 This is an important step in providing you with the best possible program. Your assistance in this effort is appreciated. Listed below are the items we need:

- 1. Team Information Form (list of players, coaches, etc.; and list of all games played; fill out online on the UIL website-www.uil. utexas.edu)
- 2. Team Picture- color, overnight or email to UIL office
- 3. Picture of Head Coach (head and shoulder shot), overnight or email to UIL office
- 4. School's Mascot (camera ready art work if possible, if not a copy of the mascot from your letterhead, etc.), overnight or email to UIL office
