Be Diligent

As professionals involved in teaching and molding young lives into productive citizens through competition, we must be diligent and conscientious. Meaning, we must position ourselves to be successful in all aspects of our job, in and out of competition.

Some coaches worry that they will not be rehired, or maybe reassigned if they don't win a certain number of games each year. Many times it is not the wins that get the coaches in trouble, but lack of diligence. The lack of diligence in the administrative part of the job will draw the ire of the parents and local administration. The lack of diligence is hard to overcome once it has happened.

We all have responsibilities for the UIL, officials, local administration, parents and players that we must satisfy. The one responsibility that seems to get overlooked most often is our membership to the TGCA. Our membership allows us a few benefits that non-members do not get. The major benefit is being able to nominate our players for a variety of awards. If we forget to renew or join the TGCA then we fail our responsibilities to the players and parents. Without question when this happens, the local admin-

istration gets involved and tries to satisfy the parents and players. In some cases this may be done at the expense of the coach.

Every year, we coaches get busier and busier. At the end of school and in the summer, we have graduations, camps, clinics, summer league and a variety of other non-required obligations in the summer. During this time we must try and find time to recharge for the upcoming school year. Many times these activities interfere with the TGCA Summer Clinic, and in order to recharge, we must sacrifice the clinic. If this occurs, then

diligence on our part should be stressed to maintain our membership in good standing. This may mean follow through with our Athletic Director, secretary and business office to make sure dues are sent in a timely manner.

Once we have joined or renewed our membership, we should consider what it means. We can nominate our players and coaches for awards, plus as a coach we can now receive awards for the job that we do. When given this benefit from the association we must be professional in our nominations. Are we entitled to an All-State player each year if we do not make the playoffs? How about an All-Star? If we are not diligent, and choose self-fulfillment over professionalism, then we fail our responsibility to our association. If we become selective in our process, then the awards become much more meaningful.

If we execute with a diligent effort in our non-competitive jobs, requiring serious application, as we do in competition, then the outcome should be favorable for all involved. If we do not, then we are subjected to second guessing with less virtuous intentions.

Sam became Executive Director of TGCA in 2001 and moved to Austin. I stayed behind in Lubbock to run my court reporting firm. It is a major portion of my duties, and includes working with all All-Star teams in all sports to ensure that we have complete teams and that their gear is ordered

correctly from our sponsors. I also work with our hotels and the convention center where we hold the clinic, along with Sam, to ensure that reservations and bookings go smoothly. Another of my duties includes registration at all of our clinics. I also ensure that all clinicians have been notified, contracts have been signed, and travel arrangements have been made.

I am also charged with preparing all materials in preparation of Board of Directors meetings and all committee meetings, to include nominations and selection forms for All-State, Academic All-State, Athletes of the Year, Coaches of the Year, All-Stars and All-Star Coaches for each sport.

These are just a few of the duties the administrative assistant performs for this association. I am here to assist you with any problems you may have and to help procure answers to any questions that you may pose. We are striving to make your association the best that it can be, and your input is extremely valuable to us. I want to take this opportunity to thank you for your patience and understanding in the transition of new personnel within the TGCA office, and I wish you the very best in the year ahead.

4X4 Grad Plan

4 X 4 Graduation Plan Concerning Athletic Credits

The State Board of Education (SBOE) passed four credits for four years participation in athletics on the 4 x 4 distinguished, recommended, and minimum graduation plans on second reading last Friday, January 15, 2010, at the William B. Travis Building in Austin, Texas. A collaborated effort by the Texas Girls Coaches Association, Texas High School Athletic Directors Association, and the Texas High School Coaches Association helped make the dream - initially originated by Craig Agnew, an assistant football coach from Brenham with a son affected by the 4 x 4 graduation requirement restrictions on credits for athletics - become a reality for all student/athletes, after two years of public testimony and extensive negotiations. All coaches in the state of Texas owe a debt of gratitude to Bob Craig, SBOE board member from Lubbock, for taking the initiative to correct an injustice and championing the cause for athletics. Members of the Texas High School Athletic Directors Association Gil Garza (President), Robert Young (Past President), and Sheri Stice did a tremendous job of giving public testimony and answering any and all questions on the subject. After two years, it just goes to show: PATIENCE IS A VIRTUE, NOT A SIN!

Nomination Instructions

TGCA Instructions for On-line Honors Nominations

Below are the instructions for completing TGCA honors nominations on-line.

Please read these instructions and follow them precisely and your nomination should go through with no problems.

- 1) Access the TGCA website at www.austintgca.com.
- 2) Click on the sport tab at the top of the main page you are nominating honors for.
- 3) Click on "Nominate Athlete" in the menu on the left-hand side of the page. You will also use this for nominating honors for All-Star Coaches, Coaches of the Year, etc.
- 4) You will be required to log in at this point. Your user name is ALWAYS your TGCA membership number. If you don't know your number, please contact us and we will be happy to give it to you. Your password, if you've not logged on to the system before, will also be your membership number. If you've already accessed the website and logged in, your password will be whatever you have created it to be. If you do not remember your password, we do not have it. You will need to contact us so that we may reset your password, and you will need to go through the complete log in process over again, including changing your password. When prompted to change your password, please keep in mind that the "Old Password" category will also be your membership number.
- 5) Once you've completed the log-in process, you will access a page that reads, "Welcome Coach " and your name. In the tabs menu at the top of that page, click on "Nominations".
- 6) Next click on the "Nomination Begin" category in the menu on the left-hand side of the page. If you nominated athletes last year, your nominations will appear from last year and will say "Locked." You can no longer access these nominations.
- 7) Click on the "Add Honors Nomination" category in the menu on the left-hand side of the page. Once you have nominated athletes, you can return to this page and see what nominations you have made by clicking on "List Honors Nominations".
- 8) Your e-mail information will be listed on this page. This is the e-mail address your nomination confirmation will be sent to. PLEASE be sure your e-mail address is correct. If your e-mail address is incorrect, you will need to click the "Update Profile" category in the menu at the top of the page and correct your e-mail address, or you will not receive your nomination confirmation. If you do not need to make changes, click the sport you are nominating for. Scroll to the bottom of the page and click the "Select Category Step Two" button.
- 9) Click the button next to the category you are nominating for (All-Star, All-State, Academic All-State, etc.). Next click the button "Enter Nominee Info Step Three".
- 10) Complete the form by typing in the information requested in the "Update" field.
- 11) When you get to the "School:ISD" field, please begin typing your school. This is very IMPORTANT! Your school must appear exactly as it is in our database for your nomination to be correctly entered. As you type, a text pop up box will appear under the school line. Please click on the correct school in this box and please pay careful attention to the school you select, making sure it is the correct school.
- 12) Continue completing the form. If you need to add additional information regarding your nominee or their accomplishments, please do so in the large text box at the bottom of the page.
- 13) When you have completed the form, please click the "Finish" button at the bottom of the page. If, for some reason, your form was not filled out correctly, you will receive an error message after clicking the "Finish" button. If you did not receive the error message, your nomination went through successfully, and you should receive a confirmation e-mail at the e-mail address you have given us. If you fail to receive a confirmation e-mail, please contact us.


